Subject: City picnic temporary liquor by the drink license

Department: Finance

Diana's Club has submitted application and fees for a City picnic temporary liquor license to sell malt liquor in excess of 3.2% of Alcohol by weight, but not in excess of 5% of Alcohol by weight and light wines containing not in excess of 14% Alcohol for consumption on the premises where sold. The license fee is \$10. The license will be issued for a period of one day, July 12, 2014. The event will be held at 200 E. Walnut.

Per Municipal Code Sec. 3-10, said permit shall be issued for only six hours on the day named therein and it shall not authorize the sale of aforesaid malt liquor for more than six hours by any said organization as described above in any fiscal year.

The applicant has met the requirements set forth in the Municipal Code Chapter 3, Alcoholic Beverages.

**Submit:** Notarized Application  
Copy of managing officer's voter's registration card  
Application Fee

**City Council:** Your application will be presented to the City Council. You are encouraged to attend the meeting. City Council meets on the first and third Tuesday of each month in the Council Chambers, 120 S. Ash, Nevada Missouri at 7:00pm.

**State Liquor Control:** Upon City Council approval, the City Licensing Officer will issue a letter of approval addressed to State Liquor Control.

**State Liquor License:** Mail or bring a copy of your state Liquor License to:

**City Liquor License:** A City Picnic Liquor License will then be issued.

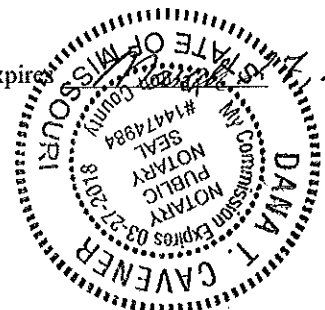
