**Time Requirement:** Application and supporting documentation must be submitted a minimum of 15 business days prior to the Council meeting.

**City Council:** City Council meets on the first and third Tuesday of each month in the Council Chambers, 120 S. Ash, Nevada, Missouri at 7:00 p.m. Your application will be placed on the agenda as a resolution requiring one read for approval. Applicants are encouraged to attend the meeting, however it is not required.

**State Liquor Control:** Upon City Council approval, the City Licensing Officer will issue a letter of approval addressed to State Liquor Control. This letter will be mailed to the applicant or may be picked up at 110 S. Ash. Include this letter with your State application.

**City Liquor License:** The City liquor license will be issued after receipt of the State license.

**License Period:** August 1 – July 31

- For the privilege of manufacturing and brewing in the city malt liquors containing not in excess of 5 percent of alcohol by weight, the license fee shall be \$300.00 per year.
- For the privilege of manufacturing in the city intoxicating liquor containing not in excess of 22 percent of alcohol by weight, the license fee shall be \$150.00 per year
- For the privilege of manufacturing, distilling or blending intoxicating liquor of all kinds within the city, the license fee shall be \$300.00 per year.
- For the privilege of manufacturing wine or brandy in the city not in excess of 18 percent of alcohol by weight for wine, or not in excess of 34 percent of alcohol by weight for brandy, the license fee shall be \$7.50 for each five hundred gallons or fraction thereof of wine or brandy produced up to a maximum fee of \$450.00 per year.
