Time Requirement: Application and supporting documentation must be submitted a minimum of 15 business days prior to the Council meeting.

City Council: City Council meets on the first and third Tuesday of each month in the Council Chambers, 120 S. Ash, Nevada, Missouri at 7:00 p.m. Your application will be placed on the agenda as a resolution requiring one read for approval. Applicants are encouraged to attend the meeting, however it is not required.

State Liquor Control: Upon City Council approval, the City Licensing Officer will issue a letter of approval addressed to State Liquor Control. This letter will be mailed to the applicant or may be picked up at 110 S. Ash. Include this letter with your State application.

City Liquor License: The City liquor license will be issued after receipt of the State license.

hereby makes application for a license to sell:

- For the privilege of selling in the city intoxicating liquor in excess of five percent of alcohol by weight in the original package, at retail and not for consumption on the premises, the license fee shall be \$150.00 per year. This license shall also permit the holder thereof to sell malt liquor of all kinds in the original package direct to consumer and not for resale.
- For the privilege of selling malt liquors containing in excess of 3.2 percent alcohol by weight, but not in excess of five percent by weight in the original package and not for consumption on the premises, direct to consumers and not for resale, the license fee shall be \$75.00.
- For the privilege of selling malt liquor not in excess of 3.2 percent alcohol by weight in the original package and not for consumption on the premises, direct to consumers and not for resale, the license fee shall be \$22.50 per year.
- For the privilege of selling malt liquors containing in excess of 3.2 percent alcohol by weight and not in excess of five percent by weight, by the drink at retail for consumption on the premises where it is sold, or light wines containing not in excess of 14 percent alcohol by weight, or both, by the drink at retail for consumption on premises where it is sold, the license fee shall be \$75.00.
- For the privilege of selling malt liquors containing not in excess of 3.2 percent alcohol by weight, by the drink at retail for consumption on the premises where it is sold, the license fee shall be \$37.50.
- For the privilege of selling intoxicating liquor in excess of five percent of alcohol by weight, by the drink for consumption on the premises, the license fee shall be \$450.00 per year; provided that the establishment shall have qualified in all ways for a state liquor license under RSMo § 311.095, 1969
