PUBLIC HEARING: Sewer Use Ordinance, Sewer Rates, and User Fee Schedule

The City Manager gave a brief introduction and turned it over to Katie Bruegge and Sarah Struby. They provided an overview of the proposed changes to Chapter 28 of the City's Code, increasing of the rates for sewer services, and setting a User Fee Schedule. The public will have 30 days to submit any written comments and there will be a second public hearing at the March 3rd City Council Meeting.

Marvin Knoche asked when the last change on sewer rates and was advised it was in 2020. He also asked about user fees and the last update will September 2025.

No other concerns were raised, and the public hearing closed at 7:26 p.m.

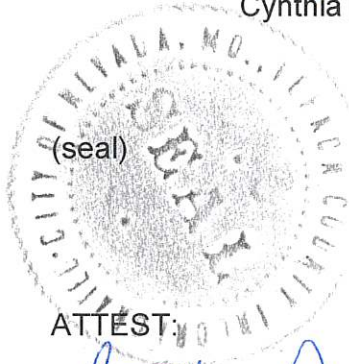
