ORDINANCE NO. 8622

A SPECIAL ORDINANCE OF THE CITY OF NEVADA, MISSOURI, AUTHORIZING AN AGREEMENT WITH INETVISIONS, LLC FOR MANAGED COMPUTER AND NETWORK SERVICES

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NEVADA, MISSOURI THAT:

Section 1. Inetvisions of Nevada, Missouri is locally owned and operated providing a full range of IT services. They currently manage 9 school districts, 21 businesses and 3 local government facilities.

Section 2. The Agreement attached hereto as Exhibit A and incorporated herein by reference is approved as an obligation of the City of Nevada, Missouri.

Section 2. The City Manager and City Clerk are authorized and directed to authorize the agreement on behalf of the City.

MAINTENANCE AGREEMENT

WHEREAS, **City of Nevada**, hereinafter called "Purchaser" and **Inetvisions LLC**, hereinafter called "Contractor" have agreed to initiate a maintenance agreement for service to the computer equipment owned by Purchaser.

SERVICES PROVIDED: Contractor will supply monthly maintenance to Purchaser computers, servers and networking equipment (patches, virus protection, backups and software, and monitoring). Contractor will also provide emergency repair service (non 8x5), as required, in a timely manner and usually within 6 hours, also will provide regular repair (8x5 regular business hours) and support within 24 hours. This contract covers regular maintenance labor and service calls remote and on site. All costs of replacement parts (hardware) are the sole responsibility of the Purchaser. Purchaser will provide valid software licenses for operating systems.

COMPENSATION: Contractor's monthly fee for this service will be Eight Thousand Two Hundred Fifty dollars (\$8250.00) per month. Payment Terms If needed, scheduled services can be changed to meet Purchaser's special needs. Any labor provided for AMC (Add, Move, Change) thereafter will be assessed at \$95.00 per hour. Emergency support outside of business hours (8x5) will be billed at \$125.00 per hour.

PAYMENT TERMS: Payment terms require invoices to be paid within 30 days (NET 30 Terms). Invoices not paid within 30 days of receipt will incur 2% late fee per month. Non-payment exceeding 120 days will incur 15% penalty and all associated collection costs. Other payment terms can be negotiated if the City of Nevada does not have a finance system in place that can meet the payment terms above. Modified payment terms must be agreed to in writing prior to contract execution.

DURATION OF CONTRACT: This contract becomes effective on January 1, 2024 and will run for three (3) consecutive years. After 1 year, it can be extended by agreement of both parties.

BY THE SIGNATURES below, the parties accept this agreement as before listed in the above contract and the contract is in effect on January 1, 2024.
