NOW, THEREFORE, BE IT RESOLVED, that the Council finds and declares that: Miranda Clark-Selby received the highest number of votes; that Bill Miles received the second highest number of votes; that Lyndon Eberhard received the third highest of votes; that Jack Somers received the fourth highest of votes; and that April D. Hendren received the lowest number of votes, and;


The four candidates receiving the highest number of votes are nominated for the two offices of councilperson, and;



Said election was duly held with proper notice given in accordance with the State law. Said certified notice is on file in the office of the City Clerk.


