

**A GENERAL ORDINANCE OF THE CITY OF NEVADA, MISSOURI, AMENDING CHAPTER 7 OF THE CODE OF NEVADA, MISSOURI, REDUCING ON THE DATES STATUTORILY REQUIRED, THE VIDEO SERVICE PROVIDER FRANCHISE FEE ON THE GROSS RECEIPTS OF VIDEO SERVICE PROVIDERS IMPOSED BY THE CITY OF NEVADA, MISSOURI**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NEVADA, MISSOURI, THAT:**

**Section 1.** Section 7-21 of the Code of the City of Nevada, Missouri imposing a 5% video service provider franchise fee on gross receipts of video service providers is hereby amended by addition by the following clauses to Section 7-21 (b):

**Adjustment of Fees  
Beginning 08/28/2023**

(a) All other provisions of Chapter 7 of the Code of the city of Nevada, Missouri notwithstanding franchise fees imposed by the city of Nevada, Missouri, from August 28, 2023 are hereby reduced to and limited prospectively to those established by the amended Missouri Legislative amended enabling act, Section 67.2689.2, RSMo. The city will not charge or collect, after the effective dates of the new legislature "CAPS" on said fee, a video service provider fee on gross receipts of video service providers, in excess of those permitted by said amended statute. More specifically: the video service provider fee so charged by the City of Nevada will reduce to and not exceed the following:

<b>Beginning August 28, 2023</b>	<b>4½ percent</b>
<b>Beginning August 28, 2024</b>	<b>4 percent</b>
<b>Beginning August 28, 2025</b>	<b>3½ percent</b>
<b>Beginning August 28, 2026</b>	<b>3 percent</b>
<b>Beginning August 28, 2027 and continuing thereafter</b>	<b>2½ percent</b>


(b) The City Manager and Treasurer of the City of Nevada, Missouri are hereby authorized and directed to make any correction or collection modifications reasonably required to the end that the city of Nevada Missouri fully complies with the collection limitations imposed by Section 67.2689, RSMo, and any amendment hereafter thereto. Any adjusting refunds demanded to fully comply with enabling statute, § 67.2689, RSMo,

will be subject to the approval of the city manager and will be reported in routine monthly financial reports to the city council.
