An Employment agreement between Mark Mitchell and the City of Nevada.

CONTRACT FOR ADVISORY SERVICE

This agreement is made and entered into as of the 1st day of March 2024 between the City of Nevada, Missouri, a Missouri Municipal Corporation, 110 S. Ash, Nevada, Missouri, (hereinafter CITY) and Mark Mitchell, dba Mark A Mitchell, dba Mitchell Municipal Government Efficiency Consultants as follows:

- 1.1. Contract Completion: Assessments and Advisory Consultations will be completed and communicated to municipal officials by March 31, 2024.
- 1.2. Duties. Mr. Mitchell will provide suggestions and advice to the City Council and to city employees to promote education and efficiency in execution of the responsibilities of municipal government.
- 1.3. Working Hours. Mr. Mitchell shall devote sufficient time at municipal facilities to analyze and improve efficiency of municipal officials and provide assistance as deemed reasonable to promote and improve the skills of current employees in discharge of their duties in the management of the affairs of the City. Hours are flexible but will meet or exceed the requested subjects by the Mayor.
- 1.4. Compensation. \$3,800 per month per contract - independent contractor without employment benefits or workers compensation coverage. Mr. Mitchell is an independent contractor neither expecting or entitled to benefits other than the contract price.
- 1.5. IRS Reporting Compliance. The city will comply with IRS requirements. His contract compensation will be reported to the IRS by Form 1099.


