BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NEVADA, MISSOURI, THAT:


Section 1. The agreement between the City of Nevada, Missouri, and DB Disposal, LLC, attached hereto and incorporated herein by reference is hereby approved.


