**A RESOLUTION OF THE CITY OF NEVADA, MISSOURI, REVIEWING THE CERTIFICATE OF ELECTION RESULTS FOR THE MUNICIPAL GENERAL ELECTION HELD ON APRIL 2, 2024 FOR A WATERWORKS AND SEWERAGE SYSTEM REVENUE BOND**



**NOW, THEREFORE, BE IT RESOLVED**, it is hereby found by the City Council of the City of Nevada, Missouri that a majority of the qualified voters of the City of Nevada, Missouri, approved a combined waterworks and sewerage system revenue bonds in the amount of \$15,000,000 for the purpose of extending and improving the combined waterworks and sewerage system of the City, including acquiring land and rights of way, the cost of operation and maintenance of said combined waterworks and sewerage system and the principal of and interest on said revenue bonds to be payable solely from the revenues derived by the City from the operation of its combined waterworks and sewerage system, including all future improvements and extension thereto.


