**A SPECIAL ORDINANCE OF THE CITY OF NEVADA, MISSOURI, AUTHORIZING THE EXECUTION OF AN AGREEMENT WITH THE NEVADA R-V SCHOOL DISTRICT FOR TWO (2) SCHOOL RESOURCE OFFICERS**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NEVADA, MISSOURI, THAT:**


**Section 1.** The agreement attached hereto as "Exhibit A" and incorporated herein by reference is approved as a contractual obligation of the City of Nevada, Missouri.

**Section 2.** The City Manager or his designee is authorized and directed to execute the same on behalf of the City of Nevada, Missouri, and is authorized to take all reasonable steps necessary to comply with the terms of the agreement.

**Section 3.** This ordinance shall be in full force and effect from and after its passage and adoption.

**Subject:** Nevada R-V School District School Resource Officer Agreement

**Department:** Police

This is an agreement between the Nevada R-V School District and the City of Nevada to provide two (2) full time School Resource Officers for the Nevada R-V School District. The Nevada R-V School District will fund the salary and benefit costs for the School Resource Officers.

**INTERGOVERNMENTAL AGREEMENT**

**BETWEEN**

**THE CITY OF NEVADA**

**AND**

**THE NEVADA R-V SCHOOL DISTRICT**

**FOR**

**THE LOCAL GOVERNMENT DISTRICT PARTNERSHIP PROGRAM**

This agreement is entered into by the City of Nevada (hereinafter referred to as "City") and the Nevada R-V School District (hereinafter referred to as "District"). The District desires to provide safety and security for all students of the Nevada R-V School District, and want to ensure that violations of State or Municipal law do not impede the ability of students to receive a full education.

The City and District agree to participate in a cooperative program to reduce and prevent crime and violence in schools.

**THE CITY OF NEVADA AND THE NEVADA R-V SCHOOL DISTRICT AGREE AS FOLLOWS:**

1. The District will fund the cost of salary, benefits, and mileage for two School Resource Officers, to reduce and prevent crime and violence in schools. The District will fund the School Resource Officers in full for the 2024-2025 school term.
2. The program will include two City of Nevada commissioned police officers who will be assigned to work for the contract period of twelve (12) months, or part thereof, (the 2024-2025 school term including the 2025 summer school) in the Nevada R-V School District in accomplishing this cooperative program to prevent crime and violence in schools.
3. The District will fund equipment and training required for this program, during the 2024-2025 school terms. Equipment and training required will be at the discretion of the District except for training that is required by all City of Nevada commissioned police officers. Equipment funded by the District will remain the property of the District upon termination of this agreement.
4. The officers assigned to this program will receive training and program direction from the District while payroll will continue to be provided through the City of

Nevada. Supervision will be shared between the City and District. The officers will work from an office(s) in a Nevada R-V School facility.

5. The District will be billed for the School Resource Officers wages and benefits the first (1st) of August of each year prior to the beginning of the school term, with payments being rendered within forty-five (45) days by the District.
6. This agreement will terminate at the end of the 2024-2025 school term. The City and District may negotiate an agreement to provide funding for the future school terms.
7. If approved by the City Council and District, this agreement may be amended to include funding from outside grant sources at a later date. Unless approval to amend this agreement is obtained from the City and the District to include other funding, should it become available, the District will in force as solely funded this agreement until the conclusion of the 2024-2025 school term.
