

RESOLUTION NO. 1835

A RESOLUTION OF THE CITY OF NEVADA, MISSOURI, ACCEPTING THE BID AND AUTHORIZING PAYMENT TO SHOW ME DEMO FOR THE DEMOLITION OF 109 E. CHERRY AS PART OF THE CITY SQUARE DEVELOPMENT PROJECT

WHEREAS, the City of Nevada, Missouri, is advancing the City Square Development Project to enhance public spaces and foster community development; and

WHEREAS, the City requested bids from specialized companies experienced in demolishing historical properties to ensure the project is conducted safely and professionally; and

WHEREAS, the City received three bids and, after careful review, recommends awarding the contract to Show Me Demo, the best and lowest bidder, with a not-to-exceed cost of \$29,300; and

WHEREAS, The City Manager or his designee is hereby authorized to execute the necessary agreements with Show Me Demo and to issue payment upon satisfactory completion of the demolition, in accordance with the terms of the contract and subject to the not-to-exceed amount specified.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Nevada, Missouri, accepts the bid and authorizes payment to Show Me Demo for the demolition of 109 E. Cherry as part of the City Square Development Project.


