

RESOLUTION NO. 1886

A RESOLUTION OF THE CITY OF NEVADA, MISSOURI, AUTHORIZING THE FILING OF AN APPLICATION AND ASSOCIATED TASKS WITH THE MISSOURI DEPARTMENT OF NATURAL RESOURCES, FINANCIAL ASSISTANCE CENTER'S FUNDING PROGRAMS FOR LOANS AND/OR GRANTS UNDER THE MISSOURI CLEAN WATER LAW (CHAPTER 644, REVISED STATUTES OF MISSOURI (RSMO)) OR THE MISSOURI SAFE DRINKING WATER LAW (CHAPTER 640, RSMO)

WHEREAS, pursuant to the terms of the Missouri Clean Water Law, Chapter 644, RSMo, or the Missouri Safe Drinking Water Law, Chapter 640, RSMo, the State of Missouri has authorized the making of loans and/or grants to authorized applicants to aid in the planning, design, and/or construction of specific eligible projects; and


WHEREAS, the City of Nevada, Missouri, desires to pursue such funding in order to undertake necessary improvements to its water and/or wastewater systems; and

WHEREAS, it is necessary to designate an individual with the legal authority to act on behalf of the City of Nevada in all matters relating to such applications and funding agreements; and

WHEREAS, City Manager Gary Edwards is hereby designated as the authorized representative of the City of Nevada, Missouri, for purposes of acting on the City's behalf in all matters relating to said application and any resulting agreements.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Nevada, Missouri, that the City Council appoints City Manager, Gary Edwards, as the authorized representative for the City of Nevada, Missouri.



Notes:

This resolution authorizes City Manager Gary Edwards to act as the official representative for the City of Nevada in applying for financial assistance through the Missouri Department of Natural Resources. The funding, available under the Missouri Clean Water Law and Safe Drinking Water Law, may be used for water and/or wastewater system improvements.

This specific grant we are applying for will assist in developing a facility plan for the Wastewater Treatment Plant. The City recently received a new operating permit that includes requirements that may be difficult to meet in the future. Completing a facilities plan is a necessary step to qualify for potential funding through the State Revolving Fund (SRF) program for any needed improvements.

The grant provides up to \$50,000, with a required \$30,000 match from the City.
