Subject: Fees and Charges for FY 2022 – Shelter Houses, Marmaduke Building,  
Twin Lakes Sports Complex Ball Fields

Department: Parks and Recreation

At their December 2, 2021 meeting, the Park Board reviewed the proposed Fees and Charges Schedule for fiscal year 2022 at the Park Shelter Houses, Col. John Marmaduke Community Building, and Twin Lakes Sports Complex Ball Fields. After discussion, the park board recommends approval of the proposed fees and charges, including the addition of Davis Park and site supervisor for tournaments and practices.

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NEVADA, MISSOURI, THAT:**

**Section 1.** The following fees for use of the Park Shelter Houses, Colonel John Marmaduke Community Building and Twin Lakes Sports Complex Ball Fields shall become effective January 1, 2022.
