

**A GENERAL ORDINANCE OF THE CITY OF NEVADA, MISSOURI, AMENDING CHAPTER 6 OF THE MUNICIPAL CODE OF THE CITY OF NEVADA, MISSOURI CONCERNING FLOOD MANAGEMENT UPDATES.**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NEVADA, MISSOURI THAT:**

**Section 1.** Portions of Chapter 6 of the Code of the City of Nevada, Missouri, are amended as hereafter provided.

**Section 2.** Section 6-73 is hereby amended by replacing the phrase "Article 1, Section B (1)" with the phrase "Article 1, Section 6-72 (1)".

**Section 3.** Section 6-81 is hereby amended by replacing the phrase "Article 2, Section A" with the phrase "Article 2, Section 6-74".

**Section 4.** Section 6-86 is hereby amended by replacing the phrase "Article 4, Section A(2)" with the phrase "Article 4, Section 6-85(2). Section 6-86 (b) is hereby amended by replacing the phrase "Article 3, Section C(9)" with the phrase "Article 3, Section 6-83(9)".

**Section 5.** Section 6-87 (3) is hereby amended by replacing the phrase "Article 4, Section C(2)" with the phrase "Article 4, Section 6-87(2)".

**Section 6.** Section 6-88 is hereby amended by replacing the phrase "Article 2, Section A" with the phrase "Article 2, Section 6-74". Section 6-88 (3) is hereby amended by replacing the phrase "Article 4, Section D(2)" with the phrase "Article 4, Section 6-88(2)". Section 6-88 (4) is hereby amended by replacing the phrase "Article 4, Section A(2)" with the phrase "Article 4, Section 6-85(2)".

**Section 7.** Section 6-91 is hereby amended by replacing the phrase "Article 5, Section A" with the phrase "Article 5, Section 6-90".


**Section 8.** Section 6-95 is hereby amended by replacing the phrase "Article 5, Sections D and E" with the phrase "Article 5, Sections 6-93 and 6-94". Section 6-95 (2) is hereby amended by replacing the phrase "Article 4, Section A (4)(b)" with the phrase "Article 4, Section 6-85 (4)(b)". Section 6-95 (3) is hereby amended by replacing the phrase "Article 4, Section A (4)(a)" with the phrase "Article 4, Section 6-85 (4)(a)". Section 6-95 (4) is hereby amended by replacing the phrase "Article 4, Section A (4)(d)" with the phrase "Article 4, Section 6-85 (4)(d)". Section 6-95 (5)

**Section 9.** This ordinance is an emergency due to the May 1, 2020 deadline it must be submitted to FEMA.

This ordinance shall be in full force and effect from and after its date of passage and approval.
