ORDINANCE NO. 8292

A SPECIAL ORDINANCE OF THE CITY OF NEVADA, MISSOURI, ACCEPTING A CONTRACT AND AUTHORIZING PAYMENT.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NEVADA, MISSOURI THAT:

Section 1. The agreement attached hereto as Exhibit "A" and incorporated herein by reference is approved as a contractual obligation of the City of Nevada, Missouri.

Section 2. The City Manager is hereby directed to authorize and execute payment.

Section 3. This ordinance is an emergency ordinance requiring immediate passage. This ordinance must be passed in order to avoid additional interest charges.

Section 4. This ordinance shall be in full force and effect from and after its adoption and approval.



Thank you very much for the opportunity to work with you on this matter.


