

A SPECIAL ORDINANCE OF THE CITY OF NEVADA, MISSOURI ESTABLISHING A FEE SCHEDULE FOR THE USE OF THE FRANKLIN P. NORMAN CITY COUNTY COMMUNITY CENTER.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NEVADA, MISSOURI, THAT:

Section 1. The following fees for use of the Franklin P. Norman City County Community Center shall become effective January 1, 2018.


