ORDINANCE NO. 8138

A SPECIAL ORDINANCE OF THE CITY OF NEVADA, MISSOURI, AUTHORIZING THE EXECUTION OF AN AGREEMENT WITH HEARTLAND AIRSHOWS OF RAYMORE, MISSOURI FOR CONSULTING SERVICES.

Section 1. The agreement attached hereto as Exhibit "A" for the contractual obligation between the City of Nevada and Heartland Airshows for a "not-to-exceed" amount of \$3,000.00.

Section 2. The City's Tourism Fund is hereby budgeted for dedication for payment to establish and hold said Airshow Consultant.

Section 3. The City Manager and City Clerk are hereby authorized and directed to execute said agreement and related documentation on behalf of the City of Nevada, Missouri and to affix the municipal seal thereto and to attest the same.



Dear Mark,

Pursuant to our meeting of late to discuss your plans to create and develop one or more aviation events over a period of two years to include a fly-in and eventually leading to an airshow, of which both dates are yet to be determined, I have agreed to engage and provide my services to you in connection with the aforementioned proposed events.

I want to thank you for selecting me and Heartland Airshows to provide you with our services in this matter.

My fees for services are based on the type of event(s) you wish to conduct. There are many variations of the types of events we have previously discussed and a final fee determination will be made when we have decided the actual type and complexity of the event(s) to occur at the Nevada Airport.

I estimate the fee for consulting services in the development of your event will be quite minimal as I usually include those into the fee for the actual execution of the event. For the first year's event of a one-day fly-in, with one of my announcers providing narration and commentary and securing a required music license as applicable, I currently estimate a fee of approximately \$1,500.00. Please remember and consider that this is an estimate and may be subject to change depending on additions and other requirements. A separate contract will be prepared when dates and the level of complexity of event is finalized.


I do not require a deposit at this time. A deposit will be required shortly after the date for the first year's event has been determined and any scheduling conflicts have been resolved. Typically, the deposit is \$500.00 and non-refundable. This covers the cost of applying for and paying for the music license.
