

**A SPECIAL ORDINANCE OF THE CITY OF NEVADA, MISSOURI,

ALL OF LOT ONE (1) COUNTRY CLUB ADDITION AND ALL THAT PART OF LOT TWO (2) OF SAID COUNTRY CLUB ADDITION, LYING NORTH OF A LINE DESCRIBED AS FOLLOWS: BEGINNING AT A POINT ON THE WEST LINE OF SAID LOT TWO (2), THENCE 51 FEET SOUTHERLY ALONG SAID WEST LINE FROM THE NORTHWEST CORNER OF SAID LOT TWO (2), THENCE EASTERLY IN A STRAIGHT LINE TO A POINT IN EAST LINE OF SAID LOT TWO (2), WHICH IS HALFWAY BETWEEN THE NORTHEAST AND SOUTHEAST CORNER OF SAID LOT TWO (2), MEASURED ALONG SAID EASTERLY LINE, (ALSO KNOWN AS THE NORTHERLY HALF OF SAID LOT TWO (2), TO THE CITY OF NEVADA, MISSOURI, AS PER THE RECORDED PLAT THEREOF, IN VERNON COUNTY, MISSOURI. ALL PROPERTY SUBJECT TO ANY PART LYING IN THE PUBLIC ROADWAY, ALSO, SUBJECT TO ANY EASEMENTS, RESERVATIONS AND RESTRICTIONS AFFECTING SUBJECT PROPERTY.
