ORDINANCE NO. 8132

A SPECIAL ORDINANCE OF THE CITY OF NEVADA, MISSOURI ESTABLISHING A FEE SCHEDULE FOR THE USE OF THE PARKS AND RECREATION SHELTER HOUSES, COLONEL JOHN MARMADUKE COMMUNITY BUILDING AND TWIN LAKES SPORTS COMPLEX BALL FIELDS.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NEVADA, MISSOURI, THAT:

**Section 1.** The fees listed in Exhibit A for use of the Parks and Recreation shelter houses, Colonel John Marmaduke Community Building and Twin Lakes Sports Complex ball fields shall become effective January 1, 2017.

**Section 2.** This ordinance amends and supersedes user fees heretofore proposed by City ordinance.

**Section 3.** This ordinance shall be in full force and effect from and after its passage and adoption.


