

RESOLUTION NO. 1581

A RESOLUTION OF THE CITY OF NEVADA, MISSOURI REVIEWING THE CERTIFICATE OF ELECTION RESULTS OF THE APRIL 6, 2021 MUNICIPAL ELECTION REPLACING THE EXISTING ONE HALF CENT (1/2 CENT) TRANSPORTATION SALES TAX UPON ITS EXPIRATION BY APPROVING A ONE-HALF CENT (1/2 CENT) TRANSPORTATION SALES TAX, FOR THE PURPOSE OF FUNDING TRANSPORTATION.

WHEREAS, the City Council of the City of Nevada, Missouri has carefully reviewed the certificate of election, hereby attached, of the Municipal Election replacing the existing one half cent (1/2 cent) transportation sales tax upon its expiration by approving a one-half (1/2 cent) transportation sales tax, for the purpose of funding transportation held on the fourth (6th) day of April, 2021, in the City of Nevada, Missouri, and;


