

RESOLUTION NO. 1560

A RESOLUTION OF THE CITY OF NEVADA, MISSOURI REVIEWING THE CERTIFICATE OF ELECTION RESULTS OF THE JUNE 2, 2020 MUNICIPAL ELECTION ISSUING ITS COMBINED WATERWORKS AND SEWERAGE SYSTEM REVENUE BONDS IN THE AMOUNT OF \$15,000,000 FOR THE PURPOSE OF EXTENDING AND IMPROVING THE WATERWORKS OF THE CITY, INCLUDING ACQUIRING LAND AND RIGHTS OF WAY, THE COST OF OPERATION AND MAINTENANCE OF SAID COMBINED WATERWORKS AND SEWERAGE SYSTEM AND THE PRINCIPAL OF AND INTEREST ON SAID REVENUE BONDS TO BE PAYABLE SOLELY FROM THE REVENUES DERIVED BY THE CITY FOR THE OPERATION OF ITS COMBINED WATERWORKS AND SEWERAGE SYSTEM, INCLUDING ALL FUTURE IMPROVEMENTS AND EXTENSIONS THERETO.

WHEREAS, the City Council of the City of Nevada, Missouri has carefully reviewed the certificate of election, hereby attached, of the Municipal Election issuing its combined waterworks and sewerage system Revenue Bonds in the amount of \$15,000,000 for the purpose of extending and improving the waterworks of the City, including acquiring land and rights of way, the cost of operation and maintenance of said combined waterworks and sewerage system and the principal of and interest on said Revenue Bond to be payable solely from the revenues derived by the City of the operation of its combined waterworks and sewerage system, including all future improvements and extensions thereto held on the second (2nd) day of June, 2020, in the City of Nevada, Missouri, and;

WHEREAS, the City Council finds that the votes were cast at said election for issuing its combined waterworks and sewerage system Revenue Bonds in the amount of \$15,000,000 for the purpose of extending and improving the waterworks of the City, including acquiring land and rights of way, the cost of operation and maintenance of said combined waterworks and sewerage system and the principal of and interest on said Revenue Bond to be payable solely from the revenues derived by the City of the operation of its combined waterworks and sewerage system, including all future improvements and extensions thereto as follows:






