

**RESOLUTION NO. 1536**

**A RESOLUTION OF THE CITY OF NEVADA, MISSOURI REVIEWING THE CERTIFICATE OF ELECTION RESULTS OF THE AUGUST 6, 2019 SPECIAL ELECTION ORDINANCE NO. 8269, IMPOSING A GENERAL CITY SALES TAX FOR THE CITY-OWNED NEVADA REGIONAL MEDICAL CENTER AT A RATE OF ONE-HALF OF ONE PERCENT (1/2 OF 1%) ON THE RECEIPTS FROM ALL RETAIL SALES OF PROPERTY OR SERVICES WITHIN THE CITY WHICH ARE SUBJECT TO TAXATION BY THE STATE OF MISSOURI UNDER THE PROVISIONS OF SECTIONS 144.010 TO 144.525, RSMO. SUCH SALES TAX TO BE TERMINATED WHEN THE HOSPITAL'S REVENUE BONDS NOW OUTSTANDING HAVE BEEN RETIRED OR WHEN TERMINATED BY THE CITY COUNCIL, WHICHEVER OCCURS FIRST.**

**WHEREAS**, the City Council of the City of Nevada, Missouri has carefully reviewed the certificate of election, hereby attached, of the Special Election Ordinance No. 8269, imposing a general city sales tax for the city-owned Nevada Regional Medical Center at a rate of one-half of one percent (1/2 of 1%) on the receipts from all retail sales of property or services within the City which are subject to taxation by the State of Missouri under the provisions of Sections 144.010 to 144.525, RSMo. such sales tax to be terminated when the Hospital's revenue bonds now outstanding have been retired or when terminated by the City Council, whichever occurs first held on the six (6th) day of August, 2019, in the City of Nevada, Missouri, and;

**WHEREAS**, the City Council finds that the votes were cast at said election Ordinance No. 8269, imposing a general city sales tax for the city-owned Nevada Regional Medical Center at a rate of one-half of one percent (1/2 of 1%) on the receipts from all retail sales of property or services within the City which are subject to taxation by the State of Missouri under the provisions of Sections 144.010 to 144.525, RSMo. such sales tax to be terminated when the Hospital's revenue bonds now outstanding have been retired or when terminated by the City Council, whichever occurs first as follows:




**NOW, THEREFORE, BE IT RESOLVED**, it is hereby found by the City Council of the City of Nevada, Missouri that a majority of the qualified voters of the City of Nevada, Missouri, approved Ordinance No. 8269, imposing a general city sales tax for the city-owned Nevada Regional Medical Center at a rate of one-half of one percent (1/2 of 1%) on the receipts from all retail sales of property or services within the City which are subject to taxation by the State of Missouri under the provisions of Sections 144.010 to 144.525, RSMo. such sales tax to be terminated when the Hospital's revenue bonds now outstanding have been retired or when terminated by the City Council, whichever occurs first.




