- For the privilege of operating and maintaining a wholesale place of business or warehouse located within the state, from which malt liquor containing not in excess of five percent alcohol by weight are sold at wholesale to a person duly licensed to sell such malt liquor at retail, the license fee shall be \$75.00 per year.
- For the privilege of operating and maintaining a wholesale place of business or warehouse, located within the city, from which intoxicating liquor, containing not in excess of 22 percent of alcohol by weight, of which are sold at wholesale to a person duly licensed to sell such liquors at retail, the license fee shall be \$150.00 per year.
- For the privilege of operating and maintaining a wholesale place of business or warehouse, located within the city, from which intoxicating liquor of all kinds are sold at wholesale to a person duly licensed to sell such liquor at retail, the license fee shall be \$375.00 per year.
- For the privilege of operating a wholesale place of business or warehouse located within the city, from which malt liquor containing not in excess of five percent alcohol by weight are sole at wholesale to a person duly licensed to sell such malt liquor at retail
- For the privilege of operating a wholesale place of business or warehouse located within the city limits from which intoxicating liquor, containing not in excess of 22 percent of alcohol by wright is sold at wholesale to a person duly licensed to sell such liquors at retail.
- For the privilege of operating a wholesale place of business or warehouse located within the city from which intoxicating liquor of all kinds are sold at wholesale to a person duly licensed to sell such liquor at retail.
