

**RESOLUTION NO. 1519**

**A RESOLUTION OF THE CITY OF NEVADA, MISSOURI APPROVING AN AGREEMENT FOR TRANSFER OF AIRPORT ENTITLEMENT FUNDS.**

**WHEREAS**, The City of Nevada has received airport entitlements under section 47114(c) of the U.S. Transportation Act, and;

**WHEREAS**, the 2015 fund allocation will not be utilized by the City of Nevada prior to its expiration on September 30, 2018 and;

**WHEREAS**, it is preferable to make the funds available to another Missouri airport project, rather than allow the entitlement to expire.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Nevada, Missouri that the attached Agreement for Transfer of Entitlements is hereby approved and adopted.

Subject: Airport Entitlement Funds Transfer

Department: Administration

The Nevada Airport is apportioned entitlement funds each year by the Missouri Department of Transportation for use in airport projects. According to Title 49 of the U.S. Transportation Code, these funds must be utilized within three years. The City of Nevada currently has \$150,000 in available funds that must be utilized prior to September 30, 2018. We will not utilize these funds prior to that date. The attached Agreement for Transfer of Entitlements will allow MoDOT to make these funds available to another Missouri airport project, rather than allowing the entitlement to expire.
