**A RESOLUTION OF THE CITY OF NEVADA, MISSOURI APPROVING LIQUOR LICENSE APPLICATIONS TO SELL INTOXICATING LIQUOR IN THE ORIGINAL PACKAGE FROM AUGUST 1, 2016 THROUGH JULY 31, 2017.**

**WHEREAS**, all applicants must provide a copy of their 2016-2017 State of Missouri Liquor License before city liquor license is issued, and;


**WHEREAS**, all applicants have met the requirements of the city to be licensed to sell intoxicating liquor in the original package.

Subject: Intoxicating Liquor in Original Package License Applications

Department: Finance

The businesses listed below submitted applications and fees for a City liquor license to sell intoxicating liquor in excess of five percent of alcohol by weight in the original package, at retail and not for consumption on the premises. The license fee is \$150.00. The license term will be for a period of one year beginning August 1, 2016 and ending July 31, 2017.

The Municipal Code limits the number of intoxicating liquor in original package to ten licenses. One license is allowed for each unit of 800 of population. City population at the 2010 census was 8,386.

All of the applicants have met the requirements set forth in the Municipal Code Chapter 3, Alcoholic Beverages.
