**A RESOLUTION OF THE CITY OF NEVADA, MISSOURI APPROVING LIQUOR LICENSE APPLICATIONS TO SELL INTOXICATING LIQUOR IN EXCESS OF FIVE PERCENT OF ALCOHOL BY WEIGHT, BY THE DRINK FOR CONSUMPTION ON THE PREMISES WHERE SOLD FROM AUGUST 1, 2016 THROUGH JULY 31, 2017.**
