A RESOLUTION OF THE CITY OF NEVADA, MISSOURI APPROVING FRANK E. PETERS MUNICIPAL GOLF COURSE APPLICATION TO SELL MALT LIQUORS AND LIGHT WINES BY THE DRINK FOR CONSUMPTION ON THE PREMISES WHERE SOLD.

WHEREAS, Frank E. Peters Municipal Golf Course located at 17320 E. Quail Road, is owned and operated by the City of Nevada, Missouri, and;

WHEREAS, Frank E. Peters Municipal Golf Course has submitted an application for a liquor license to sell malt liquors not in excess of five percent alcohol and light wines not in excess of 14 percent alcohol by the drink for consumption on the premises where sold;

WHEREAS, the applicant has met the requirements of the city,

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Nevada, Missouri that the application is hereby approved.

Application For City License to Sell Beer or Liquor Under the
Provisions of the Non-Intoxicating Beer Act or
Liquor Control Act of 1935

To the Honorable City Council of the City of Nevada, Missouri:

The undersigned, hereby makes application for a license to be granted for sale by him of:

- For the privilege of selling in the city intoxicating liquor in excess of five percent of alcohol by weight in the original package, at retail and not for consumption on the premises, the license fee shall be \$150.00 per year. This license shall also permit the holder thereof to sell malt liquor of all kinds in the original package direct to consumer and not for resale.
- For the privilege of selling malt liquors containing in excess of 3.2 percent alcohol by weight, but not in excess of five percent by weight in the original package and not for consumption on the premises, direct to consumers and not for resale, the license fee shall be \$75.00.
- For the privilege of selling malt liquor not in excess of 3.2 percent alcohol by weight in the original package and not for consumption on the premises, direct to consumers and not for resale, the license fee shall be \$22.50 per year.
- For the privilege of selling malt liquors containing in excess of 3.2 percent alcohol by weight and not in excess of five percent by weight, by the drink at retail for consumption on the premises where it is sold, or light wines containing not in excess of 14 percent alcohol by weight, or both, by the drink at retail for consumption on premises where it is sold, the license fee shall be \$75.00.
- For the privilege of selling malt liquors containing not in excess of 3.2 percent alcohol by weight, by the drink at retail for consumption on the premises where it is sold, the license fee shall be \$37.50.
- For the privilege of selling intoxicating liquor in excess of five percent of alcohol by weight, by the drink for consumption on the premises, the license fee shall be \$450.00 per year; provided that the establishment shall have qualified in all ways for a state liquor license under RSMo § 311.095, 1969.

Under provisions of the applicable act of 1935 (Non-Intoxicating Beer Act-Liquor Control Act of Missouri) such sales to be on the following described premises only, to-wit: Brandy Lile, **Managing Officer for** Frank E Peters Golf Course, 17320 So Quail Rd, in the Company Name Frank E Peters Golf Course, Company Physical Address 17320 So Quail Rd, in the

City of Nevada, County of Vernon and State of Missouri. The applicant states that he has applied for and been granted a license for such purposes by the County Clerk of Vernon County, Missouri, said license being conditioned upon the granting to the applicant of the City License herein applied for; that the applicant herein is now making application for a license and permit for such purpose to be granted by the Supervisor of Liquor Control of the State of Missouri and it is understood and agreed that the City License applied for shall not be in force and effect unless and until such state permit or license is issued to the applicant for the premises above described. The applicant agrees that when and if said license be issued to him he will obey and abide by all lawful ordinances, regulations and rules adopted by said City in the conduct of said business. The applicant represents that he is in all respects qualified in law to receive such license. It is understood and agreed that the license when and if issued shall be subject to revocation for cause by the City Council and when and if lawfully revoked for cause, no part of the fee paid shall be returned to the applicant.
