Subject: Annual liquor license applications
Intoxicating Liquor by drink

Department: Finance

The businesses listed below have submitted applications and fees for a City liquor license to sell intoxicating liquor in excess of five percent of alcohol by weight, by the drink for consumption on the premises. The license fee is \$450. The license term will be for a period of one year beginning August 1, 2014 and ending July 31, 2015.

The Municipal Code does not limit the number of intoxicating liquor by the drink licenses.

All of the applicants have met the requirements set forth in the Municipal Code Chapter 3, Alcoholic Beverages.

WHEREAS, Vipas Thai Place, 3 Js LLC dba Iguana Azul, Los Sauces, Fraternal Order of Eagles, Ol Subway, Nevada Country Club, Fraternal Order of Bears, American Legion, Buzz's BBQ and Nevada Elks Lodge have submitted applications for a liquor license to sell intoxicating liquor in excess of five percent of alcohol by weight, by the drink for consumption on the premises where sold, and;
