Subject: Frank E Peters Municipal Golf Course Fee Schedule

Department: Parks and Recreation

During the August 26, 2015 meeting of the Park Board, they discussed the fee structure for the Frank E Peters Municipal Golf Course. Due to an increase in operating and maintenance expenses, they voted unanimously to recommend an increase in annual fees as follows:

Adult Season Pass	from \$475 to \$485
Senior Season Pass	\$375 to \$383
Additional Pass	\$250 to \$255
Student Pass	\$135 to \$138
College Pass	\$175 to \$180
Family Pass without Cart	\$750 to \$765
Family Pass with Cart	\$1275 to \$1300
Season Cart	\$650 to \$660
Annual Trail Fee	\$500 to \$525

A SPECIAL ORDINANCE OF THE CITY OF NEVADA, MISSOURI ESTABLISHING A FEE STRUCTURE FOR THE USE OF THE FRANK E PETERS MUNICIPAL GOLF COURSE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NEVADA, MISSOURI, THAT:

Section 1. The following fees for use of the Frank E Peters Municipal Golf Course shall become effective January 1, 2016
