Subject: Replacement Compressor and Cascade System

Department: Fire

Bids were solicited from three companies for a replacement compressor, cascade, and fill station to replace the 15 year old equipment currently used. The equipment specified in the bid included: 1-Bauer 10 hp Enclosed Single Phase Compressor, 1- Bauer CFSII-2S two bottle fill station, 1- 4 Cyl 6000 Psi Cascade system with accessories. The following three companies were asked to bid either a new or used system meeting the specifications listed:

Feld Fire- \$21,500.00

North Central Air- \$45,785.00

Conrad Fire Equipment- \$35,996.20

The bid of \$21,500.00 from Feld Fire meets the specifications as listed and can be delivered to the fire station by the end of February 2016. Funding for this purchase will be 100-5-2200-327.

All storage assembly components are shipped as loose items and installation, assembly, and interconnecting piping to an existing system are the responsibility of the installer, unless they are purchased factory installed in a storage rack as a complete assembly..

Available Storage Racks

RCK-0037 is a heavy duty universal two-position welded steel rack designed for use in horizontal or vertical applications. In addition, these racks can be bolted together to form multiple cylinder storage systems. Two CMP-0106 per cylinder position are included as part of the scope of supply of the RCK-0037. These racks are available as loose items or as part of a complete DOT storage assembly. Each RCK-0037 weighs approximately 130 lbs. See the following referenced outline dimensional drawings:

ASY-0759, Vertical assemblies

ASY-0758, Horizontal assemblies

The customer is to specify orientation of rack assembly at time of order. Examples follow:

- 1 x 2 Vertical, specifies two vertical racks side by side
- 2 x 1 Vertical, specifies two vertical racks one in front of the other

SUBMISSION OF BIDS:

Bids must be priced, signed and returned (with all necessary attachments) to the office of the City Clerk by the closing date and time specified.

The bidder must respond to this RFB by submitting all data required herein in order for the bid to be evaluated and considered for award.

Written assurance that the quoted rate/price will be honored for at least 30 days to allow for reasonable and expeditious processing by City staff and the City Council.

Price quotes are to be F.O.B. delivered at Nevada, Missouri. Payment terms and date of delivery of product must be described as a part of your bid.
