**WHEREAS**, the City of Nevada, Missouri desires membership in the Kaysinger Basin Regional Planning Commission, and;

**WHEREAS**, the City Council of the City of Nevada, Missouri authorizes such membership and financial participation, and;

**WHEREAS**, the City of Nevada, Missouri has determined that the regional program can assist in guiding unified development, eliminate planning duplication and will provide economy and efficiency in the coordinated economic development of the area.

**NOW, THEREFORE BE IT RESOLVED THAT**, the City of Nevada, Missouri, participate through membership in the Kaysinger Basin Regional Planning Commission, and that financial contribution of \$.22/Capita (total \$1844.92) as has been determined by the Commission.

**BE IT FURTHER RESOLVED THAT**, the City Council hereby appoints, J. D. Kehrman, City Manager or his designee, to represent the City of Nevada, Missouri on the Kaysinger Basin Regional Planning Commission.

**PASSED, APPROVED AND ADOPTED**, this 3rd day of May, 2016.

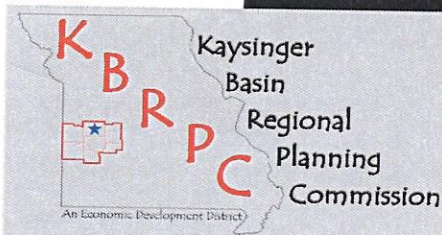

As summer approaches so does another year at the Kaysinger Basin Regional Planning Commission (KBRPC). Since 1968, member communities have enjoyed the benefits that KBRPC has offered. This coming fiscal year will bring numerous opportunities for your community to excel in economic and community development, educational events, and more. Programs such as Economic Development, Brownfields Assessment, and Engineering are just some of the continued projects available in this coming year. Your membership is vital for KBRPC to bring these projects and future opportunities to this region, and for the success of our region as a whole.

When KBRPC was organized in 1968 by the cities, villages and counties in the seven (7) county region, the idea was to pool local membership fees to support a professional staff which would assist local communities within the region. The amount of services KBRPC offers has increased over the years, however the membership fees have not. So, in March of 2016, the KBRPC Board of Directors unanimously voted to increase the municipal membership rate for the first time since 1974 from .20 per capita to .22 per capita, based on the 2010 census population figures. This increase was determined by calculating inflation on the Bureau of Labor Statistics' Consumer Price Index (CPI). In addition to the programs listed above, your annual membership entitles your city to the following services:

1. Partnership with MoDOT including annual prioritization of projects
2. Updated Hazard Mitigation Plans every 5 years
3. Grant writing services
4. Opportunities associated with the Missouri Association of Councils of Governments (MACOG)
5. Economic Development assistance, including EEZ management
6. Mapping services
7. Consultations at any time with the Director or staff
8. A constant resource for funding opportunities and ideas

With this minimal increase and clear definition of services, KBRPC hopes to be able to better assist the communities within the region.

We ask that you please return your assessment in conjunction with the enclosed invoice by **June 30<sup>th</sup>, 2016**. Along with your remittance, please be sure to include the completed "Resolution of Membership" form. This form requests an officially designated representative from your governing body to be a member of the KBRPC Full Commission, which is comprised of a

representative from each membership community. The KBRPC Board of Directors itself is then made up of three (3) members of each county and meets bimonthly. This Full Commission appointment does not imply that the person will be a member of the Board of Directors, however they will be the point of contact for KBRPC staff, will get the opportunity to attend all board meetings and can relay vital information back to the city councils.

Thank you for your continued support of KBRPC and your investment in your community and our entire region.
