Subject: Franklin P. Norman City County Community Center Fee Schedule

Department: Parks and Recreation

The proposed fee schedule includes an average 2% increase to offset the cost of operations and infrastructure improvements. Daily rentals are discounted 60% compared to hourly rentals and non-profit entities are discounted 20% compared to regular rates.

ORDINANCE NO.

A SPECIAL ORDINANCE OF THE CITY OF NEVADA, MISSOURI ESTABLISHING A FEE SCHEDULE FOR THE USE OF THE FRANKLIN P. NORMAN CITY COUNTY COMMUNITY CENTER.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NEVADA, MISSOURI, THAT:

Section 1. The following fees for use of the Franklin P. Norman City County Community Center shall become effective January 1, 2017.
