ORDINANCE NO.

A SPECIAL ORDINANCE OF THE CITY OF NEVADA, MISSOURI ESTABLISHING A FEE SCHEDULE FOR THE USE OF THE WALTON AQUATIC CENTER.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NEVADA, MISSOURI, THAT:

Section 1. The following fees for use of the Walton Aquatic Center shall become effective January 1, 2017.
