

**RESOLUTION NO. 1484**

**A RESOLUTION OF THE CITY OF NEVADA, MISSOURI REVIEWING THE CERTIFICATE OF ELECTION RESULTS OF THE APRIL 4, 2017 MUNICIPAL ELECTION REPLACING THE EXISTING ONE HALF CENT (1/2 CENT) TRANSPORTATION SALES TAX UPON ITS EXPIRATION BY APPROVING A ONE-HALF CENT (1/2 CENT) TRANSPORTATION SALES TAX, OVER A FIVE (5) YEAR PERIOD, FOR THE PURPOSE OF FUNDING TRANSPORTATION.**

**WHEREAS**, the City Council of the City of Nevada, Missouri has carefully reviewed the certificate of election, hereby attached, of the Municipal Election replacing the existing one half cent (1/2 cent) transportation sales tax upon its expiration by approving a one-half (1/2 cent) transportation sales tax, over a five (5) year period, for the purpose of funding transportation held on the fourth (4th) day of April, 2017, in the City of Nevada, Missouri, and;

**WHEREAS**, the City Council finds that the votes were cast at said election for replacing the existing one half cent (1/2 cent) transportation sales tax upon its expiration by approving a one-half (1/2 cent) transportation sales tax, over a five (5) year period, for the purpose of funding transportation as follows:
