Subject: Chapter 3, Section 3-27 Sale of Intoxicating Liquor and Beer for

Consumption on Premises Around the Public Square Waiver

Department: Finance

The annual Bushwhacker Days Celebration will be held June 7th -10th, 2017.

The attached resolution will waive the provisions of Chapter 3, Section 3-27, Sale of intoxicating liquor and beer for consumption on premises around the square June 8th, 9th, and 10th, 2017 (Thursday, Friday, and Saturday).

If approved, the waiver would allow vendors and non-profit organizations to apply for a temporary permit or picnic license to sell alcoholic beverages by the drink. All other requirements of Chapter 3 Alcoholic Beverages will remain in effect and only properly licensed entities could sell and serve alcoholic beverages.

Temporary permits and picnic licenses require Council approval. The applicant must identify the consumption area, provide temporary fencing, provide signage notifying customers that Missouri law permits sales only for consumption on premises and provide employees who will require customers leaving the premises to discard unfinished drinks before exiting the premises.

Chapter 3, Section 3-27 was previously waived in 2015 for the Tour of Nevada Criterium Cycling Race.

A RESOLUTION OF THE CITY OF NEVADA, MISSOURI, AUTHORIZING A WAIVER OF MUNICIPAL CODE CHAPTER 3 SECTION 3-27 SALE OF INTOXICATING LIQUOR AND BEER FOR CONSUMPTION ON PREMISES AT ANY LOCATION ON THE PUBLIC SQUARE OR STREETS LEADING FROM THE PUBLIC SQUARE FOR A DISTANCE OF ONE BLOCK DURING THE BUSHWHACKER DAYS CELEBRATION.

WHEREAS, The Bushwhacker Days Celebration will be held June 7 – 10, 2017 and;

WHEREAS, It is the desire of City Council to waive the provisions of the Code Chapter 3-27 of the City of Nevada, Missouri June 8, 9 and 10, 2017 (Thursday, Friday and Saturday) during the Bushwhacker Days Celebration and;

WHEREAS, All provisions of the Code shall remain in effect and shall <u>not</u> be waived for Wednesday, June 7, 2017 and;

WHEREAS, all other requirements of the Code Chapter 3 Alcoholic Beverages will remain in effect and will continue to be enforced during the waiver period;

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Nevada, Missouri that provisions of Chapter 3, Section 3-27 of the Code of the City of Nevada are hereby waived June 8, 9, and 10, 2017.
