Time Requirement: Application and supporting documentation must be submitted a minimum of 15 business days prior to the Council meeting.

City Council: City Council meets on the first and third Tuesday of each month in the Council Chambers, 120 S. Ash, Nevada, Missouri at 7:00 p.m. Your application will be placed on the agenda as a resolution requiring one read for approval. Applicants are encouraged to attend the meeting, however it is not required.

State Liquor Control: Upon City Council approval, the City Licensing Officer will issue a letter of approval addressed to State Liquor Control. This letter will be mailed to the applicant or may be picked up at 110 S. Ash. Include this letter with your State application.

- For the privilege of operating and maintaining a wholesale place of business or warehouse located within the city, from which malt liquor containing not in excess of five percent alcohol by weight are sold at wholesale to a person duly licensed to sell such malt liquor at retail, the license fee shall be \$75.00 per year.
- For the privilege of operating and maintaining a wholesale place of business or warehouse, located within the city, from which intoxicating liquor, containing not in excess of 22 percent of alcohol by weight, and non-intoxicating beer, both of which are sold at wholesale to a person duly licensed to sell such liquors at retail, the license fee shall be \$150.00 per year.
- For the privilege of operating and maintaining a wholesale place of business or warehouse, located within the city, from which intoxicating liquor of all kinds and non-intoxicating beer are both sold at wholesale to a person duly licensed to sell such liquor at retail, the license fee shall be \$375.00 per year.
