WHEREAS, The Chamber of Commerce has scheduled the first annual barbeque competition to be held on Saturday, September 23, 2017 at the Elks Lodge located at 510 Centennial Boulevard and;

WHEREAS, The competition is open to local and national pit teams with the potential to become a new tradition for the Nevada area and;

WHEREAS, The Elks Lodge want to apply for temporary liquor permit for all outdoors areas at 510 Centennial Boulevard including the parking which is essential for the event and;

WHEREAS, Katy Allen Lake and Davis Park are public parks within 100 feet of 510 Centennial Boulevard and;

WHEREAS, It is the desire of City Council to waive the provisions of the Municipal Code Section 3-26 (a) Sale of Liquor Prohibited Near Schools, Churches, Parks during the event.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Nevada, Missouri that provisions of Section 3-26 (a) of the Code of the City of Nevada are hereby waived September 23, 2017 during the event.

Low and Slow Barbecue Cook Off

The Chamber of Commerce has partnered with the Elks Lodge to host the first annual cook off. This event is open to local and national pit teams and has the potential to be a new tradition for the Nevada area.

The competition is scheduled for Saturday, September 23, 2017.

The Elks applied for a temporary liquor permit for the outdoor property at 510 Centennial Blvd. Katy Allen Lake and Davis Park border the Elks property and Municipal Code Section 3-26 (a) prohibits the sale of liquor ... "within 100 feet of any public park, school, church or other building regularly used as a place of worship..."

Full use of the outdoor area including the parking lot is essential to the event. The attached resolution will waive the provisions of Section 3-26 (a).-Sale of liquor prohibited near schools, churches, parks during the event.

If approved, Elks staff will establish visible boundaries and ensure that patrons with alcoholic beverages remain on the property.
