Subject: Local Law Enforcement Block Grant Purchase Request

Department: Police

The Nevada Police Department has been awarded grant funding from the Missouri Department of Public Safety under the Local Law Enforcement Block Grant (LLEBG) to purchase (19) Safariland Level III Duty Holsters and (19) Streamlight TLR-2 Weapon Mounted Lights for officer use on duty.

This equipment will be issued to all uniformed personnel with the goal of increasing officer safety. The holsters will replace existing equipment issued to officers and the weapon mounted lights will be new equipment issued to officers.
