

A SPECIAL ORDINANCE IMPOSING A GENERAL SALES TAX IN NEVADA, MISSOURI, FOR THE CITY-OWNED NEVADA REGIONAL MEDICAL CENTER, AND PROVIDING FOR SUCH ORDINANCE TO BE SUBMITTED TO THE QUALIFIED VOTERS OF THE CITY.

WHEREAS, the City Council of Nevada, Missouri, under the authority of powers given to the City by the provisions of Sections 94.500 to 94.550, inclusive, RSMo, as amended (the "Act"), has determined that it is in the best interests of the City to impose an additional general city sales tax for Nevada City Hospital, d/b/a Nevada Regional Medical Center, at the rate of one-half of one percent (1/2 of 1%) on the receipts from all retail sales within the City which are subject to taxation under Sections 144.010 to 144.525, inclusive, RSMo, to be terminated when the outstanding hospital revenue bonds issued by the City have been retired or when terminated by the City Council, whichever occurs first: and

WHEREAS, Nevada is now collecting a one percent (1%) sales tax under the authority of the Act:

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NEVADA, MISSOURI, AS FOLLOWS:

Section 1. A general city sales tax for the city-owned Nevada Regional Medical Center at the rate of one-half of one percent (1/2 of 1%) on the receipts from all retail sales within Nevada, Missouri, is hereby imposed upon all sellers within the City for the privilege of engaging in the business of selling tangible personal property or rendering taxable services at retail to the extent and in the manner provided by Sections 144.010 to 144.525, inclusive, RSMo, and the rules and regulations of the Director of Revenue of the State of Missouri issued pursuant thereto. Such tax shall not be effective until the terms and provisions of this Ordinance have been complied with and shall be terminated when the City's hospital revenue bonds now outstanding have been retired or when terminated by the City Council, whichever occurs first.

Section 2. This Ordinance shall be submitted to the voters of Nevada, Missouri, at an election to be held in the City on Tuesday, August 6, 2019. The form of Notice of Special Election containing the question of approval of this Ordinance, a copy of which is attached hereto and made a part hereof, is hereby approved. The City Clerk is hereby authorized and directed to notify the County Clerk of Vernon County, Missouri, of the passage of this Ordinance no later than 5:00 P.M. on Tuesday, May 28, 2019, and to include in said notification all of the terms and provisions required by Chapter 115, RSMo.

Section 3. If this Ordinance is approved by a majority of the votes cast by the qualified voters voting thereon at said election, the City Clerk shall as soon as possible after the election date (but in any event no later than ten (10) days after the election date) forward to the Director of Revenue of the State of Missouri by United States registered mail or

certified mail (1) a certified copy of this Ordinance, including the Notice of Special Election attached hereto, and (2) a copy of the abstract of votes cast on the question at said election. The general city sales tax for the city-owned Nevada Regional Medical Center hereby imposed shall then become effective on January 1, 2020, and shall be levied and collected in the manner provided by the Act, by Sections 32.085 and 32.087, RSMo, as amended, and by all other applicable laws, and shall be used for the purpose hereinabove authorized and shall be terminated when the Hospital's revenue bonds now outstanding have been retired or when terminated by the City Council, whichever occurs first.

Section 4. This Ordinance shall be in full force and effect from and after its passage and approval.
