Subject: Golf Course Rough Mower

Department: Parks & Recreation

The City recently requested bids for a new Golf Course Rough Mower for the Parks & Recreation Department's Twin Lakes Maintenance division. This unit replaces a tractor/wing mower unit.

Request for Bids was advertised on Friday, January 17, 2020 in the local newspaper, and emailed to potential bidders. Bids were opened on Tuesday, January 28, 2020 at 10:30 a.m., with the following results:

Kansas Golf & Turf, Lenexa KS	\$60,780.00
Professional Turf Products, Lenexa KS	\$63,004.74
Van Wall, Olathe KS	No Bid

The lowest and best bid received was from Kansas Golf & Turf, of Lenexa KS, for provision of a new golf course rough mower unit, as per bid specifications. Staff recommends said purchase.

Funding for this project is budgeted in 280-5-5700-320 (\$59,780).







**Returns Policy:**

1. All returns are subject to restocking, refurbishing, usage, and shipping fees.
2. All returns must be able to be sold as new.
3. Items missing parts are non returnable.
4. Professional Turf Products will have sole discretion as to the resalable condition of the product.
