Subject: No Parking Zones

Department: Police Department

This ordinance will amend section 19-123 of the Municipal Code, updating the designated no parking zones throughout the City of Nevada. Revisions to several designated no parking zones have been requested by the Nevada R-5 School District and Cottey College while other modifications are based on a comprehensive review by the Nevada Police Department.

ORDINANCE NO.

A GENERAL ORDINANCE OF THE CITY OF NEVADA, MISSOURI, AMENDING CHAPTER 19 OF THE NEVADA CITY CODE PERTAINING TO NO PARKING ZONES.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NEVADA, MISSOURI, THAT:

Section 1. Section 19-123 of the Nevada City Code is hereby amended to read as follows:

Section 19-123. – No parking zones.

The following have been designated as no parking zones by the City Manager, with the approval of the City Council, in accordance with section 19-126.1 of the Code. When signs are erected giving notice thereof in accordance with section 19-128 of the Code, no person shall at any time park a vehicle upon any of the following described streets or parts of streets:

1. **Adams Street**, west side, from Austin Boulevard to Cherry Street.
2. **Adams Street**, east side, between Douglas Street and a point 45 feet south of the south curb line on the south side of Pitcher Street.
3. **Adams Street**, east side, from a point 184 feet north of Barr Street to a point 15 feet south of the north curb line of Barr Street.
4. **Adams Street**, east side, between a point 20 feet north of the north driveway entrance to the Moore-Few Care Center and a point 40 feet south of the south entrance to the Moore-Few Care Center parking lot.
5. **Adams Street**, west side, from a point 89 feet north of the entrance to the Medical Arts Building parking lot to a point 30 feet south of the south entrance to the Nevada Medical Clinic parking lot.
6. **Ash Street**, both sides, from the north curb line of the north side of Austin Boulevard to Hunter Street.
7. **Ash Street**, east side, between Hunter Street and the north boundary of the Nevada Community Center parking lot.
8. **Ash Street**, west side, between Hunter Street and a point 85 feet north of the north curb line of Hunter Street.
9. **Ash Street**, east side, between Hickory Street and a point 150 feet south of the south curb line of Hickory Street.
10. **Ash Street**, east side, between Hickory Street and a point 150 feet north of the north curb line of Hickory Street.

11. **Ash Street**, west side, between Hickory Street and a point 150 feet south of the south curb line of Hickory Street.
12. **Ash Street**, west side, between Hickory Street and a point 150 feet north of the north curb line of Hickory Street.
13. **Ashland Street**, both sides, between Adams Street and Ash Street.
14. **Ashland Street**, north side, beginning 23 feet east of the east drive to the Nevada High School parking lot north of Ashland and ending even with the east side of the furthest west driveway into Truman Elementary.
15. **Ashland Street**, south side, between North Tucker and the east side of the furthest west driveway into Truman Elementary.
16. **Ashland Street**, north side, between Washington Street and the north intersection of Ashland Street and Commercial Street.
17. **Atlantic Street**, north side, from Olive Street to Main Street.
18. **Atlantic Street**, south side, from Adams Street to Cedar Street.
19. **Atlantic Street**, south side, from a point 173 feet west of the west curb line of Washington Street to Lynn Street.
20. **Barr Street**, north side, from a point 20 feet east of the Barr Street entrance to the Medical Arts Building parking lot to the west side of the alley that is located approximately 20 feet west of the Barr Street entrance to the Medical Arts Building parking lot.
21. **Barr Street**, south side, from a point 20 feet east of the Barr Street entrance to the Nevada Medical Clinic parking lot to a point 20 feet west of the Barr Street entrance to the Nevada Medical Clinic parking lot.
22. **Cherry Street**, south side, from Ash Street to a point 48 feet west of the west curb line Ash Street.
23. **Cherry Street**, north side, from Chestnut Street to a point 100 feet west of the west curb line of College Street.
24. **Cherry Street**, south side, from Chestnut Street to the east entrance to the Haidee and Allen Wild Center for the Arts parking lot.
25. **College Street**, east side, from Austin Boulevard to a point 195 feet south of the south curb line of Austin Boulevard.
26. **College Street**, west side, from Austin Boulevard to a point 80 feet south of the south curb line of Austin Boulevard.
27. **Douglas Street**, south side, from Adams Street to the west side of the furthest west drive into Nevada Regional Medical Center.

28. **Hickory Street**, south side, between Washington Street and Ash Street and the north side from Ash Street to a point 55 feet east of the east curb line of Ash Street.
29. **Hickory Street**, both sides, between Ash Street and a point 75 feet west of the west curb line of Ash Street.
30. **Highland Avenue**, north side, between Ash Street and West Street.
31. **Highland Avenue**, south side, beginning at a point 132 feet east of the east curb line of Washington Street and continuing east to North Osage Street.
32. **Highland Avenue**, north side, between North Osage Street and a point 475 feet west of the west edge of North Osage Street.
33. **Lynn Street**, east side, between Austin Boulevard and a point 200 feet north of the north curb line of Austin Boulevard.
34. **Main Street**, west side, between Austin Boulevard and Arch Street.
35. **Main Street**, west side, between Austin Boulevard and a point 50 feet north of the north curb line of Austin Boulevard; and Main Street, west side in front of 110 South Main, beginning 88 feet south of the front of the curb at the intersection of Cherry and Main Streets and continuing 47 feet south in front of 110 South Main.
36. **Main Street**, east side, between Austin Boulevard and a point 68 feet north of the north curb line of Austin Boulevard.
37. **Main Street**, east side, beginning at a point 128 feet north of the north curb line of Austin Boulevard, and continuing 20 feet north in front of 117 South Main.
38. **Osage Street**, east side, to include the 1500, 1600 and 1700 blocks to the existing no parking zone on the Missouri Department of Transportation right-of-way.
39. **Pitcher Street**, north side from Adams Street to Clay Street.
40. **Tucker Street**, east side, from Hickory Street to Allison Street.
41. **Washington Street**, east side, from Cherry Street to Austin Boulevard.
42. **Washington Street**, west side, from Austin Boulevard to a point 169 feet north of the north curb line of Austin Boulevard.
43. **Washington Street**, west side, from Austin Boulevard to Arch Street.
44. **Washington Street**, east side, from Austin Boulevard to a point 85 feet south of the south curb line of Austin Boulevard.

Section 2. This ordinance shall be in full force and effect from and after its adoption and approval.
