Subject: Fees and Charges for FY 2020

Department: Parks and Recreation

At their January 29, 2020 meeting, the Park Board reviewed the new proposed Fees and Charges Schedule for fiscal year 2020 at the Frank E. Peters Municipal Golf Course (attached). After discussion, the park board unanimously recommends approval of the proposed fees and charges, including changes to:

Season Pass – Adult (21 to 59) from \$440 to \$475

Season Pass – Senior (60+) from \$375 to \$425

Season Pass – Family + cart (2 adults, 2 under 21 yrs) from \$1,195 to \$1,300

Season Pass – Family with private cart – NEW category \$1,250

Once approved, staff will proceed with awareness campaigns. The proposed Fees and Charges would take effect for the 2020 golf season beginning April 1, 2020.

ORDINANCE NO.

A SPECIAL ORDINANCE OF THE CITY OF NEVADA, MISSOURI ESTABLISHING A FEE SCHEDULE FOR THE USE OF THE FRANK E. PETERS MUNICIPAL GOLF COURSE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NEVADA, MISSOURI, THAT:

Section 1. The following fees for use of the Frank E. Peters Municipal Golf Course shall become effective April 1, 2020.
