WHEREAS, a certificate of liability insurance for the event naming the city as an additional insured must be filed before the permit can be issued.

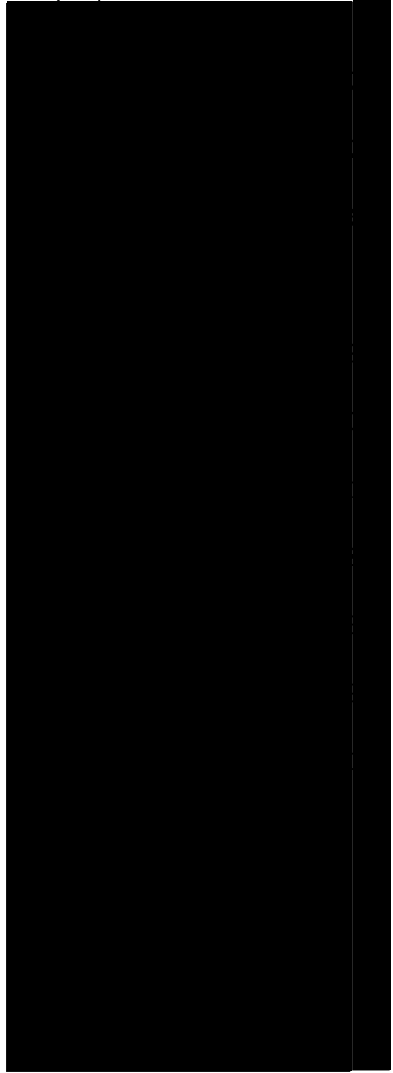

Sec. 16-132. - Soliciting money on portion of streets traveled by vehicular traffic. 

- a. No person shall stand upon that portion of the public streets of the city on which there is vehicular traffic for the purpose of solicitation of funds unless a traveled portion of right-of-way solicitation permit has been obtained from the licensing officer and approved by the city council.
- b. A person seeking the issuance of a traveled portion of right-of-way solicitation permit shall file an application with the licensing officer on forms provided by the city together with a statement of past and expected receipts and costs of collections of funds solicited for the most recent year.
- c. An application for a traveled portion of right-of-way solicitation permit shall be filed not less than 60 days prior to the proposed solicitation.
- d. The city council will issue a permit as provided for hereunder when they find that:
 1. The applicant obligates himself to not interrupt, impede or jeopardize the safe and orderly movement of traffic.
 2. The solicitation will not require the diversion of city resources as to prevent the normal provision of city services.
 3. The applicant obligates himself to not cause injury, damage to property, provoke disorderly conduct or create a disturbance.
 4. The solicitation may only be conducted at the intersections of Osage and Austin and Washington and Cherry.
 5. The permittee has performed no more than four solicitation events within any given calendar year.
- e. All applicants and permittees must:
 1. Provide with the application a certification of liability insurance of \$1,000,000.00 for the event, naming the city as an additional named insured.
 2. Establish temporary signage along the applicable roadways announcing the solicitation immediately prior to starting the solicitation event. Said signage shall be placed approximately 200 feet on each side of the solicitor and all signs shall be removed immediately after the solicitation is completed. Said signage shall be six foot square in size and freestanding. Signage must be visible to oncoming traffic, but shall not obstruct the vision of vehicles in any way.
 3. Solicit only during daylight hours, 30 minutes after sunrise and 30 before sunset.
 4. Ensure that all solicitors are 18 years of age or older.
 5. Refrain from soliciting the occupant of a vehicle unless the vehicle has come to a complete stop.
 6. Not stand in the traveled portion of the right-of-way while traffic is permitted to move by the controlling traffic control device.
 7. Restrict the number of solicitors to no more than eight persons to solicit at one intersection at one time.
 8. Wear at all times during solicitation in the right-of-way—Clothing or a vest meeting the standards for high visibility garments described as ANSI/ISEA 207-2006: American National Standard for High-Visibility Public Safety Vest.
 9. Refrain at all times from impeding or delaying traffic or otherwise jeopardizing the safety of the traveling public.
