Subject: Change Order No. 1 for APAC

Department: Public Works

Change order No. 1 with APAC-Central includes the Johnson Drive widening project surface asphalt overlay and the 1900 Block on N. Elm surface asphalt overlay with curb & gutter in the amount of \$51,309.50.

Manager Notes:

- Blevins Asphalt was contacted for bidding on these projects. They informed us they would not be able to bid due to projects already scheduled.
- Johnson Drive improvements is budgeted for 2021 including the asphalt paving. Two matured CDs were deposited for use with Johnson Drive improvements and the Bluebird building demo.
- 1900 N Elm was originally on the street list and inadvertently removed. East Edwards is on the list for repaving as well as a portion of the 1900 Block of North Elm. The additional work will extend 230' north of the Elm & Edwards intersection. The sale of the NORAM Grader (\$125,000) remaining balance will be appropriated for the additional work.

**A SPECIAL ORDINANCE OF THE CITY COUNCIL OF THE CITY OF NEVADA,
MISSOURI AUTHORIZING THE EXECUTION OF CHANGE ORDER NO. 1 TO THE
AGREEMENT WITH APAC-CENTRAL INC.**

WHEREAS, on May 18, 2021, City Council approved the low bidder APAC-Central, Inc., of Springfield, Missouri in the amount of \$466,950.00 with a not to exceed amount of \$475,000.00 for the 2021 Street Improvements and;

WHEREAS, The Johnson Drive widening project is approximately 450' of 3' surface asphalt overlay in the amount of \$29,257.50 and the 1900 Block of N Elm project is approximately 460' of 2" curb and gutter with 230' of 4" surface asphalt in the amount of \$22,052.00 with a combined total of \$51,309.50 and;

WHEREAS, The City Manager certifies funds are available for appropriation revenues in excess of those estimated in the 2021 budget.

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NEVADA, MISSOURI,
THAT:**

Section 1. The amendment to the contract for 2021 Street Improvements between the City of Nevada and APAC-Central, Inc., of Springfield, Missouri attached hereto as Exhibit "A" and incorporated herein by reference is hereby approved.

Section 2. The City Manager and City Clerk are hereby authorized and directed to execute said agreement on behalf of the City of Nevada, Missouri, and to affix the municipal seal thereto and to attest the same.

Section 3. This ordinance shall be in full force and effect after its passage.
