Subject: Liquor Control Board Appointments

Department: Administration

Appointments of three (3) members to the Liquor Control Board for the purposes of processing, overseeing, and adjudicating matters pertaining to liquor control within the City of Nevada.

Manager Notes:

- On May 17, 2022 City Council passed Ordinance 8499 amending Chapter 3 of the City of Nevada Municipal Code pertaining to Alcoholic Beverages.
- Sec. 3-23. Liquor Control Board Created – Membership – Qualifications – Vacancies – Duties.
 - (a) Created. There is hereby established a Liquor Control Board for the purposes of processing, overseeing, and adjudicating matters pertaining to liquor control within the City of Nevada.
 - (b) Membership; Qualifications. The Liquor Control Board shall consist of the three (3) members nominated by the City Manager and appointed by the City Council.
 - (c) Vacancies. In the event of any vacancies on the Liquor Control Board, a replacement will be nominated by the City Manager and approved by the City Council.
 - (d) Duties. The Liquor Control Board shall review all applications submitted to the licensing officer for a liquor license or permit, issue an approval, denial, or noninsurance regarding any complete license application presented to the Liquor Control Board, and shall preside over any hearings for the renewal, suspension, revocation, or discontinuance of any license issued by the licensing officer, **except special event licenses granted by the City Council in Section 3-11, which shall be exclusively reviewed by the City Council.**
