The term of office shall be for three years except the initial appointment will be one person for one year, two persons for two years and two persons for three years

**ORDINANCE NO.**

**A GENERAL ORDINANCE OF THE CITY OF NEVADA, MISSOURI, AMENDING SECTION 2-106 OF THE CODE OF THE CITY OF NEVADA, MISSOURI.**

**WHEREAS**, the Council of the City of Nevada, Missouri, deems it wise and necessary to enlarge the Board of Directors of the Long-Term Care operation of the City (Moore Few and Barone Center) to nine (9) members, and;

**WHEREAS**, the Mayor has nominated five (5) candidates he believes to be capable, competent, and accomplished volunteers to serve with the four (4) remaining members of the current board, and recommends a recasting of terms to provide continuity as set forth is the proposed approving resolution, and;

**WHEREAS**, the City Council wishes to approve said nominations and recast terms as recommended by the Mayor, by said resolution, should the board be enlarged, and;

**WHEREAS**, the enlarged board as recast, will be devoted to providing expanded insight and capabilities in the management of financial affairs, and operational safety, and to benefit patients, employees, and the citizens of the community;

**NOW, THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NEVADA, MISSOURI THAT:**

**Section 1.** Article XXX, of the Code of the City of Nevada Missouri, is hereby amended by the addition of the following provision:

**Section 2-106.1. Nine (9) Member Board.** Other provisions of the code notwithstanding, the board of directors of the City Convalescent Home, which operates the Moore Few Centers and the Barone Center, is hereby, this \_\_\_\_\_ day of September 2022, recast and expanded to nine (9) members, to be appointed by the Mayor forthwith and approved by the city council in conformity with Section 2-106. The members of this expanded board will serve for the terms suggested by the Mayor and approved by the council, or until their successors are selected and seated.

**Section 2.** This ordinance will be in full force and effect upon its passage and approval.
